4. Old Business

a. The actual date of our upcoming Bingo Night is Friday May 12th, 2023. It had been incorrectly noted in the March 1st meeting minutes.

5. New Business

- a. Principals Report:
 - i. Melissa Novak has returned from maternity leave effective April 17th in one of the Grade 7/8 classrooms.
 - ii. Tech Campaign donation the local Optimist Club would like to support our tech campaign. A cheque will be shared on May 5th. Once the amount is known that detail will be shared with the CSCC.
 - iii. Kindergarten enrolment is currently 27 students with the 28th registered to start on May 4th
 - 1. We had started the year with 18.
 - 2. Due to the large class size the Division has added 3 hours of EA time (Claudine Cousineau) in the morning and a half-time teacher (Alyssa Fick) for the afternoons.
 - 3. Kindergarten enrolment for Fall is currently at only 15 students.
 - iv. We are already planning for next year around enrolment, potential classroom arrangements, staffing, etc.

- 1. At this date I don't know who may or may not be moving. People on temp contracts may not return.
- v. Budget for 2023-24 will be a challenge
 - 1. Division needs to find approximately \$1.5 million in cuts to balance the budget.
 - 2. While overall provincial education budget is larger (6.5%) everyone needs to understand that enrolment growth has been significant particularly in GSCS (we have more students to teach across the province) and inflation has increased costs such as utilities, maintenance, supplies (paper) etc.
 - 3. Funding is based on September 30th enrolment. Since that date GSCS has taken in over 600 students for whom we are not funded. Specifically at St. Volodymyr we are up over 30 students since September 30th.
 - 4. Per student fnding in 2015-16 was \$10,232 and for 2023-24 it will be \$9892 If funding had kept pace with the Saskatchewan CPI, then funding should be closer to \$12,663 per student. That is approximately a \$50 Million difference. Even to be funded at 2015-16 levels of \$10, 232 would provide our Division with an additional \$6-7 million.
 - 5. May 16th is a Trustee-CSCC engagement evening where some of this will be discussed.
 - 6. "Provided Lunch" Pilot Project
 - a. This has been running for the last 5 weeks on T/W/Th, so 3 days per week.
 - b. This was targeted to specific families where a need was observed (6 students from 3 families). It could easily be at 10-12 kids if we pushed families to accept it a bit harder.
 - c. The pilot will end this week, but will provide some data with which to think about continuing the program next fall.
 - d. The main problem is finding volunteers to run it at lunch and Shawn is the person doing all the grocery shopping for it.
