### BISHOP JAMES MAHONEY HIGH SCHOOL 2024 CHEMICAL FREE AFTERGRAD EVENT RULES AND GUIDELINES

### **RULES AND CONDITIONS**

In order to ensure a safe and successful event, the following rules and conditions must be understood by the students, parents/guardians, and volunteers. The following expectations for the graduates will be strictly upheld by the Chemical Free After Grad Committee with the assistance of volunteers. The graduate will accept these rules and conditions without exception, and will respect the volunteers in attendance at the event:

- 1. Only graduates will be permitted to attend. All tickets must be pre-purchased.
- 2. Graduates will **NOT** be permitted to take their own vehicles to Prairieland Park. They need to be accompanied by a parent/guardian.
  - a. All attendees will receive an After Grad wristband during registration/security check at Prairieland Park.
  - b. All attendees must go through security check prior to admittance to Hall E.
  - c. Entrance to the event will be from 9:30 PM to 10:15 PM on June 26, 2024.
  - d. Attendees arriving late will be denied admittance. **NO EXCEPTIONS and NO REFUNDS**.
- 3. **Bags** will be allowed and will be stored at a parent supervised table. No bags are to be with the student for the duration of the event. **ALL bags** will be searched upon entry into the event. Purses and hats will **NOT** be allowed. NO LIQUIDS PERMITTED (hairspray, perfume etc.)
- 4. Parent chaperones, volunteers or event staff are not responsible for lost/stolen personal items.
- 5. NO ALCOHOL OR ANY MIND-ALTERING CHEMICAL SUBSTANCE WILL BE PERMITTED! This also includes cigarettes and vaping devices.
  - a. No one under the influence of alcohol or any mind-altering substance will be allowed to attend. All persons entering Prairieland Park Hall D and E will be assessed.
  - b. Failure to comply in any way will result in immediate expulsion from the event with no refund of ticket price.
  - c. Supervisor/volunteer will phone the parent/guardian of the offending person to inform them of the expulsion and the parent/guardian will be required to come to Prairieland Park Hall D immediately to pick them up.
  - d. If anyone is found to be in possession of drugs or alcohol the volunteers have the right to notify the Prairieland security personnel, who then have the right to detain you until Saskatoon City Police arrive. A volunteer will notify the parent/guardian to immediately come and pick up the graduate.
  - e. The "no alcohol" rule pertains to volunteers/parents/entertainers as well. This is a nonlicensed event!
- 6. If an attendee decides to leave Prairieland Park Hall D during the event, regardless of time, they must be picked up by the parent/guardian (as specified on the consent form). That individual must come into Prairieland Park (at the parent pickup entrance) and be prepared to show ID. Attendees are not allowed to leave Prairieland Park unless accompanied by a parent/guardian. Once you leave, you cannot return. NO EXCEPTIONS.
- 7. First aid will be provided by professionals. If your attendee has a medical condition that we should know about, please indicate on the consent/release form. This information will be treated in a confidential manner.
- 8. Volunteers will be present throughout the event to assist as required. Prairieland Park will also have security present. All attendees must respect the rules of the After Grad event.
- 9. Parents/guardians must pick up the graduates Prairieland Park Hall D at the conclusion of the event. The graduates will not be allowed to leave until the parent/guardian arrives and signs

**them out – so drivers must plan to park and come in to sign the form.** Attendees will not be allowed to make changes to their transportation arrangements – only the pre-designated driver (as specified on the consent form) will be allowed to drive them home.

- 10. In order to purchase tickets to the event, a completed Chemical Free Consent and Waiver Form must be presented at the time of ticket purchase. This is **mandatory** tickets will NOT be sold without a completed form.
- 11. In the event of an emergency and a parent and/or guardian needs to contact a Graduate while they are at Prairieland Park, you may call the committee co-chairs Leanne at 306-227-7448 or Jessica at 306-220-0134.

# **CHEMICAL FREE BJM 2024 AFTER GRAD**

### CONSENT AND WAIVER

The BJM High School graduating class and their parents/guardians will sponsor and plan a graduation celebration (After Grad 2024) to be held at Prairieland Park Hall D on June 26 and 27, 2024. While neither BJM school staff nor the Greater Saskatoon Catholic Schools (collectively the school) are sponsoring the After Grad 2024, the sponsors, graduates, and the school community wish to ensure a safe, responsible, and memorable celebration. Therefore, the parent organizing committee and sponsors requires each graduate to sign the following agreement as a condition of attendance.

# Agreement of the Grad:

To ensure a safe, chemical free, drug-free and alcohol-free After Grad event at Prairieland Park beginning on June 26, 2024 at 9:30 pm and ending at June 27, 2024, 1:00 am, I agree to the following conditions of attendance:

- I understand and agree that the After Grad event is for graduates only.
- This is a 100% chemical, drug and alcohol-free event (for all attending including those who may be of legal smoking and drinking age) and I agree to behave in a way that is conducive to a safe celebration. I will not consume, nor will I possess at any time, at the event site (Prairieland Park), any materials or items (drugs, vape or alcohol) that may affect my behavior or that may be used to harm others, such as any items that could be considered to be or used as weapons.
- I understand and agree that the possession of or showing the effects of drugs, alcohol, or weapons will not be tolerated and will constitute grounds for dismissal from the event and that if I behave in a way that is deemed to be disruptive to the event, I will be detained by the onsite security personnel along with a parent volunteer, and my parents/guardians will be notified to pick me up immediately. Parents/guardians will be required to sign the student out of the event.
- Any additional transportation expenses incurred as a result of dismissal from the event will be my sole responsibility. Any prohibited substance or item found in my possession will be confiscated and I understand that a report will be filed with the local law enforcement agency, if applicable.
- I understand and agree that I am expected to remain at the event for its entirety or until my parent or guardian picks me up and signs the release form. There are no in/out privileges. I understand and agree that BJM High School, and the parent sponsors along with the onsite parent volunteers are not responsible for me or any actions on my part, should I leave the event site (Prairieland Park) prior to the conclusion of the After Grad event, (scheduled to conclude at June 27, 2024 at 1:00 am), with or without their knowledge or permission. All attendants will be identified by an After Grad wristband.
- I understand and agree that I will be searched upon entry, as well as my belongings and will not bring non-essential personal articles to the event. Should I have any of these items in my

possession during the search at the time of event check-in, I will submit those items back to my parent/guardian

# Agreement of the Parent/Guardian of each Grad:

To ensure a safe, chem-free, drug-free and alcohol-free After Grad event at Prairieland Park beginning on June 26, 2024, 9:30 pm and ending on June 27, 2024, 1:00 am, I agree to the following conditions of my graduate's attendance:

- I understand and agree that the After Grad celebration is not a school sponsored event, nor is it authorized or organized by the school, and forms no part of the formal graduating ceremonies, or requirements for attendance or graduation from BJM High School, whether or not any school staff attend, assist, or are invited to the After Grad 2024.
- My/our graduate, has my permission to attend the After Grad event, taking place from June 26, 2024, 9:30 pm and ending on June 27, 2024, 1:00 am. I understand and agree that grads who attend must remain at the event for its entirety. There are no in/out privileges and will only be allowed to leave once I have picked up my/our child.
- I understand and agree to my/our graduate's requirement to abide by his or her agreement as set out above, and I agree to be available for contact at the telephone number listed below, and to attend at the site if the sponsors or the onsite After Grad parent volunteers determine for any reason that I should be notified, or that my child should leave the site as a result of a breach of their agreement, or for any other reason.
- I agree to release and hold harmless the parent sponsors/volunteers, BJM High School,
  Prairieland Park, and all agents, employees, and assignees of each for any damages suffered by
  me or my child arising from their attendance at this event.
- I am providing information regarding medical conditions/requirements, and food/drug allergies, and agree to this information being provided to onsite medical personnel if required (doctor, nurses, police).
