Improving Student Learning and Achievement

Presented by: Superintendent K. Cardinal and Coordinator Cornelia Laliberte

Background Information:

The Ministry of Education provides school divisions with data to inform planning at the provincial, division and school levels through a perceptual survey called OurSCHOOL. OurSCHOOL is a web-based survey intended to provide leading indicators of student engagement and wellness, and the aspects of classroom and school learning climate that research has shown affect student engagement and learning outcomes.

OurSCHOOL reports provide school and division-level data used to inform strategic planning. School-level data is used during the learning improvement planning process to develop goals and action plans, as well as to monitor success and make mid-course corrections.

Survey Administration and Data

Grades 4-12 students within our division participated in the OurSCHOOL survey in fall of 2022. In the spring of 2023, schools will have a choice to once again respond to this survey. Schools can access their survey results shortly after completion.

What type of information does the OurSCHOOL survey provide?

The survey includes measures of student engagement, categorized as social, institutional and intellectual engagement.

What did we learn?

OurSCHOOL data indicates that on almost all measures, Greater Saskatoon Catholic Schools is equal to the Canadian Norm in the area of positive school behaviour and slightly below the Canadian Norm in all other areas.

The OurSCHOOL Survey continues to provide school communities with meaningful data to plan for student engagement and success. School, network and division-level initiatives are better able to respond and tailor programming based on student-reported trends and patterns. In conjunction with various other sources of information, our schools continue to be places of belonging and success.

Recommendation:

That the Board of Education receive the information as presented in the 2023 OurSCHOOL Survey Results report.

6.3 First Nations, Métis and Inuit Education Monitoring Report



Board Priority:

- Improving Student Learning and Achievement
- Building Relationships and Partnerships
- Promoting Stewardship

Presented by: Superintendent K. Cardinal

Background Information:

Comprised of four First Nations, Métis and Inuit Education (FNMIE) Consultants, one Coordinator, two Program Leaders who specialize in the area of Métis education and antiracist/anti-oppressive education as well as a Manager of Community and Resource Development, the First Nations, Métis and Inuit Learning Community serves as a catalyst for creating positive change in the area of Indigenous education and student learning outcomes within Greater Saskatoon Catholic Schools. Value-added services and supports are provided in a responsive and relational manner to students, families, staff, and community facilitating their ability to enact the Truth and Reconciliation Commission's Calls to Action in their own contexts. The work of the FNMIE Learning Community is guided by the FNMIE Area of Focus plan and holds space for four priority areas: the Integration of Indigenous Epistemologies; School Collaboration; First Nations, Métis and Inuit Student Supports and Transitions; and Indigenous Language Programming. The FNMIE Area of Focus plan is reviewed and renewed annually and is influenced by community voice, innovative research practices, and ongoing community and social contexts.

After the discovery of unmarked graves in Kamloops in May of 2021 and the papal visit in July 2022 the FNMIE Learning Community has created tools and opportunities that focus on reconciliation, with a shared understanding of how students and staff can take action to reconcile and heal. These learning opportunities explore concepts such as developing an understanding of Indigenous language, ceremony, land-based learning, and cultural revitalization. Goals within the FNMIE Area of Focus plan have led to more professional learning opportunities in the area of decolonizing education and anti-racist and anti-oppressive education. These areas are especially important in societal context where we continue to understand colonization and its' continued impact, particularly in an educational setting.

While the Area of Focus plan frames the FNMIE Learning Community's practices, they continue to be sustained by providing multiple avenues of support to truth and reconciliation, sharing a commitment to mental, physical, emotional, and spiritual healing. The papal visit to Canada occurred in July 2022, and in preparation for this visit members of the team shifted their lens to better support our partnership with the Diocese. During Pope Francis's visit, members of the FNMIE Learning Community connected with the community by coordinating a prayerful gathering that would provide a space for consolation and healing.

The FNMIE Learning Community has and continues to use *Inspiring Success: First Nations and Métis PreK-12 Education Policy Framework* (Ministry of Education) as a guide for our work at both the division and school levels. Inspiring Success provides Greater Saskatoon Catholic Schools with a strong foundation that supports the team in the permeation of Indigenous ways

of knowing into learning experiences, in emphasizing culturally responsive and relational pedagogies, and in creating accountability to support truth and reconciliation at all levels. With the development of the Indigenous Responsibility Education Framework and its' upcoming implementation, the team will focus our work to align the FNMIE Area of Focus plan and school division plans with the Provincial Education Plan and Inspiring Success, striving to implement and reflect all elements using the Indigenous Responsibility Education Framework.

- Building Relationships and Partnerships

Background Information:

As a part of the March 23, 2022 provincial budget, the new Minor Capital Renewal Program was created by the Ministry of Education to address capital projects that involve structural repair, renovations, additions, and right-sizing of schools. This year's application will be our second under this program. School divisions are limited to two project submissions that are due at the same time as the Major Capital Project submissions. Projects that will be considered as a part of this application process will be evaluated using the following criteria:

- Projects need to be renovations, additions or demolitions
- Project costs need to fall within a \$1-\$10 million range
- Assessment Rubric Similar to Major Capital Projects
 - Risks (to occupants and/or surrounding community)
 - Health and Safety Current and potential risk to students and staff (Risks are only considered if they corroborated by a third-party report prepared by a certified professional)
 - Functionality/Contribution to Program (space requirements for special needs children, vulnerable students and specialized programming; Functional – culturally appropriate spaces, poor physical layout, inefficient design that limits operational usefulness or efficiency)
 - Contribution to Community (benefits to the local community)
 - Size and Cost of project

The facilities team reviewed our facilities and are proposing two projects for the board's approval. Both projects are the same as last year's submission.

Bishop James Mahoney High School

Functionality/Contribution to Program

- There is currently no second gym and the combatives room is made up of two portable classrooms. This has been a long-term opportunity for improvement at BJM. Part of our submission would include a permanent addition for a secondary gym. This space would also serve as a combatives room.
- This facility also requires a modernization that would improve aesthetics and performance while extending the life cycle. Building elements being considered are exterior windows and doors, flooring, paint and millwork throughout the facility.

Contribution to Community

- Parish partnership
- The new gymnasium would create a new space that would be available to the community for after-hours use.
- Enrolment at Bishop James has been growing; indicative of the community's support for Catholic education and the Health Sciences Academy.

Bishop Klein School

Functionality/Contribution to Program

- The facility requires a modernization that would improve aesthetics, performance while
 extending the life cycle. Building elements being considered are exterior windows and
 doors, flooring, paint and millwork throughout the facility.
- This facility has 10 modular classrooms that have been fully occupied for many years
 due to stable enrolments. Our proposal would include reducing the number of modular
 classrooms and replacing them with permanent construction. The modular classrooms
 that are removed would either be scheduled for demolition or relocated to another site.
 The relocatable classrooms were constructed from 1985-1987.

Contribution to Community

- Parish partnership
- Enrolment at Bishop Klein has been stable with some growth; indicative of the community's support for Catholic education.

Recommendation:

That the Board of Education approve Bishop Klein School and Bishop James Mahoney High School as the two projects being submitted to the Ministry of Education for consideration under the Minor Capital Renewal Program.



- Building Relationships and Partnerships

Background Information:

The Ministry of Education requests that school divisions submit projects for major capital funding one year prior to the provincial budget's approval and release.

The 2024-2025 application for major capital project funding is to be submitted by March 8, 2023. Ministry guidelines allow for each school division to submit a maximum of three projects. These projects include new school construction, replacement school construction, and addition/renovation. Projects are to be prioritized by the board at the time of submission. This year's capital projects are the same three projects submitted in 2022 with updated enrollment projections.

The current capital evaluation method used by the Ministry of Education provides a matrix to score all capital project submissions from school divisions. In the past, we have included smaller renovation or rehabilitation projects as a part of our capital requests. The Ministry of Education will now be reviewing these smaller scale projects as part of the Preventative Maintenance and Renewal (PMR) program and the Minor Capital Program which was launched in 2022. All capital project submissions are scored using the following eight categories:

Category	Maximum Points
 Health and Safety 	75 points
 Utilization 	6 points
 Efficiency 	12 points
 New Growth 	6 points
 Functionality/Contribution to Program 	3 points
 Contribution to Community 	3 points
 Facility Condition 	3 points
 Project Evaluation 	9 points

Administration has reviewed our facilities and enrollment projections in the context of the Ministry's scoring matrix to determine potential capital initiatives.

Based on an evaluation according to the above criteria, the following projects have been identified as the board's priorities for major capital funding requests. The projects are listed in ranked order:

Priority I Joint Use Holmwood Suburban Centre Catholic High School

Priority II Joint Use Catholic Middle/High School located in the region of Corman Park

between Martensville/Warman

Priority III Joint Use Brighton Catholic Elementary School

Recommendation:

That the Board of Education approve a new Joint Use Catholic high school in the Holmwood Suburban Centre, a new Joint Use Catholic middle/high school within the Martensville/Warman region of Corman Park and a new Joint Use Catholic elementary school in Brighton as the priority projects for our Major Capital Plan for the 2024-2025 submission to the Ministry of Education.

Background Information:

Section 180 of The Education Act, 1995 stipulates that the Board of Education must pass an annual resolution to approve designation of French immersion programming by February 15 of each year. Below is the list of schools that will be offering French Immersion for the 2023-2024 academic year.

The addition for this year is Grade 5 at both École St. Luke School and Father Robinson School. As a part of those new programs, we have committed to adding one grade per year.

Background Information:

Over the course of the last few years, the province has been working on the development of a provincial education plan. The Framework for a Provincial Education Plan 2020-2030 was released in November 2019. This framework was the result of the work of the planning team including a Provincial Education Summit, an online survey, and over 300 in-person engagements. The Commitment Statements and Areas of Focus were drafted by the Education Council based on the advice and guidance provided by Elders and Knowledge Keepers in 2021.

On October 17, 2022 the board of education provided feedback on the draft actions, and milestones for the long-term provincial education plan. Division administration and teachers were also invited to provide feedback on the draft plan. Following the submission of feedback from divisions across the province, the Provincial Education Plan Implementation Team (PEPIT) met and refined the actions and milestones based on the feedback provided by divisions.

On December 7, 2022 the Provincial Education Council reviewed and endorsed the priority actions and milestones, as recommended by the Provincial Education Plan Implementation Team (PEPIT).

The next step in finalizing the long-term PEP is endorsement of the priority actions and milestones for the plan by boards of education and the Minister of Education. Please note that targets and measures for the plan will be developed by the PEPIT February 2023, and that the plan is considered to be a living document that will continue to be revised and updated as necessary throughout the years of the plan to 2030. During this meeting, we will be seeking the endorsement of the PEP priority actions and milestones included in this report.

Trustees and members of executive council were treated to a wonderful meal, energizing live fiddle music and impromptu jigging. We are blessed to have this partnership. This event is one of many ways we are able to connect and celebrate with the entire team at CUMFI.

Ribbon Skirt/Shirt Day (January 4): Greater Saskatoon Catholic Schools (GSCS) celebrated Ribbon Skirt/Shirt Day on January 9. Many staff and students wore ribbon skirts and shirts as a celebration of Indigenous culture.
