Background Information:

On May 16, 2022, Greater Saskatoon Catholic Schools, in partnership with Edwards Edwards McEwen Architects, issued nine Request for Tenders (RFT) for the roof replacement at the following schools in Saskatoon:

Package #1 - Tender Close Date - June 14, 2022

- Bishop Murray High School
- Bishop Roborecki Elementary School
- St. Anne Elementary School
- École St. Paul Elementary School
- · St. Philip Elementary School

Package #2 - Tender Close Date - June 16, 2022

- École St. Gerard Elementary School
- St. Angela Elementary School
- St. Patrick Elementary School
- St. Volodymyr Elementary School

These RFT's were posted on SaskTenders to satisfy the requirements of the New West Trade Partnership Agreement and the Canadian Free Trade Agreement.

Due to the size of the tender package and at the request of the Contractors, Greater Saskatoon Catholic Schools split the due date of the award into two packages. Five (5) projects closed on June 14, 2022 and four (4) closed on June 16, 2022.

The tender responses ranged for each project as follows:

- Bishop Murray High School 5 bidders \$362,364 to \$707,491 plus PST and GST
- Bishop Roborecki Elementary School 5 bidders \$159,064 to \$346,350 plus PST and GST
- St. Anne Elementary School 4 bidders \$483,540 to \$561,800 plus PST and GST
- École St. Paul Elementary School 5 bidders \$630,778 to \$1,080,126 plus PST and GST
- St. Philip Elementary School 4 bidders \$520,086 to \$662,700 plus PST and GST

Package #2

- École St. Gerard Elementary School 4 bidders \$61,875 to \$144,060 plus PST and GST
- St. Angela Elementary School 4 bidders \$87,209 to \$156,950 plus PST and GST
- St. Patrick Elementary School 5 bidders \$282,749 to \$464,520 plus PST and GST
- St. Volodymyr Elementary School 4 bidders \$99,380 to \$156,950 plus PST and GST

Century Roofing and Sheet Metal Ltd. was the lowest tender price for Package #1 projects.

Clark Roofing (1964) Ltd. was the lowest tender price for Package #2 projects.

Background Information:

On May 31, 2022, Greater Saskatoon Catholic Schools, in partnership with Key West Engineering Ltd., issued a Request for Quotation (RFQ) for the provision and replacement of the boiler at St. Gabriel Elementary School.

This RFQ was posted on SaskTenders to satisfy the requirements of the New West Trade Partnership Agreement and the Canadian Free Trade Agreement. The RFQ close date was June 16, 2022 at which time Greater Saskatoon Catholic Schools received three quotation responses for the project.

The quotation responses ranged from \$157,975 to \$170,230.91 plus PST and GST.

Interwest Mechanical Ltd. was the lowest quotation price for the St. Gabriel Boiler Replacement project.

Recommendation:

That the Board of Education award the quotation for the St. Gabriel Boiler Replacement project to Interwest Mechanical Ltd. for the quotation price of \$157,975 plus applicable taxes.

Background Information:

On June 15, 2022, Greater Saskatoon Catholic Schools, issued a Request for Quotation (RFQ) for the provision of TOA brand audio equipment.

The Greater Saskatoon Catholic Schools' standard 'Soundfield systems' are comprised of a speaker, mixer/amplifier and wireless microphone system. The wireless microphone system is comprised of a headset mic, belt-pack transmitter and receiver. SaskTel purchased wireless frequencies from Innovation, Science and Economic Development Canada (formerly Industry Canada) that a number of the Greater Saskatoon Catholic Schools' Soundfield belt-pack transmitters and receivers operate on. It became necessary to replace the belt-pack transmitters and receivers on those systems operating on E, F and G bands to avoid interference with SaskTel's equipment, which could affect emergency calls.

This RFQ was posted on SaskTenders to satisfy the requirements of the New West Trade Partnership Agreement and the Canadian Free Trade Agreement. The RFT close date was June 21, 2022, at which time Greater Saskatoon Catholic Schools received ten quotation responses for the project.

The tender responses ranged from \$241,908 to \$365,152 inclusive of taxes.

Pro AV was the lowest quotation price to supply the equipment for the contract.

Recommendation:

That the Board of Education award the quotation for the provision of the TOA Brand Audio Equipment to Pro AV for the quotation price of \$241,908 taxes included.
