6.1 2021-2022 Budget



Board Priority:

Promoting Stewardship

Background Information:

Greater Saskatoon Catholic Schools prepares for the challenge to administering another statusquo budget during a pandemic. Greater Saskatoon Catholic Schools has been allocated an estimated provincial operating revenue of \$190,364,555 which represents a 1.34% increase over last year's allocation. While the additional funds are very much appreciated, increased costs associated with negotiated contractual increases along with inflationary costs, need to be addressed. Therefore, our relative ability year over year to provide educational services remains consistent with additional pressure to reduce as we seek ways to account for inflationary increases. For reference, this extends the reductions in services experienced in the 2017-18 budget year.

On April 6, as part of the 2021-22 provincial budget, the government announced an increase in operating funding for Pre-K to Grade 12 education of \$19.2 million or 0.98% additional funding compared to the 2020-21 school year. The additional \$19.2 million will only cover the 2% teacher agreement cost increase.

The detailed 2021-2022 Budget will be presented at the meeting and released following board approval.

Recommendation:

That the Board of Education approve the 2021-2022 Operating and Capital Budget for submission to the Ministry of Education.

6.2 Pandemic Response Update

Background Information:

This is the final pandemic response board update in this academic year. Pandemics don't fit nicely into any existing timelines or boxes, so we assume that there will be a need for some degree of updates as we resume operations in late August.

As of this report, operations of the school division for this academic year have drawn to a close, so there are no updates to report. We will use this opportunity to provide a few summary points on this year.

First, a sincere thank you to our entire community: families, students, staff, and community partners for their amazing work this year. A special thanks also to our trustees who provided solid leadership and guidance in the midst of the turmoil this year! The only constant was change and uncertainty. Despite that, everyone pulled together and responded to the new demands with grace and determination. Thanks to this concerted and united effort, we were able to continuously offer educational services with interruptions only in specific local circumstances. This was an amazing feat. In a general sense, everyone is very tired, but proud of their work this year and so they should be.

Second, we learned a great deal and grew in many ways despite the challenges. Sometimes growth is spurred by challenge: and we certainly had lots of those. As a result, we have grown in many ways not the least of which is our abilities to augment the educational experience using technology.

Third, a sincere thanks to our working partners in our local medical health office and emergency measures teams. These groups in our communities worked very well together, respecting each member's roles and expertise while supporting each other in making the best decisions possible for our communities – difficult and complex though most of the decisions were.

Fourth, a special thanks to our executive council and communications consultant who all took on new roles and expanded responsibilities as we navigated this year. Many evenings and weekends were spent working through situations, determining the pathway forward, and then communicating, communicating, communicating, and supporting. They provided exemplary service to our school communities.

And the list could go on, and on.

As we look forward to the fall, many operational questions remain. It is too far in the future to say with any certainty what operational protocols we will need to implement, so we remain engaged in the provincial and local dialogue. The timeline indicates that we should have more clarity on this in early August such that we can prepare in mid-August for September opening.

Everyone is very hopeful for a return with limited restrictions. However, we do need to be prepared with escalating responses should that be required. We have learned a great deal about these responses this year so we are in a good position moving forward.

In conclusion, life's experiences are many and varied and they help reveal our character. The extreme of this challenge has helped reveal the depth of resilience and determination in our character.

6.3 St. Frances Cree Bilingual School Existing Building and Site Demolition

Background Information:

On June 3, 2021, Greater Saskatoon Catholic Schools, in partnership with Kindrachuk Agrey Architecture, issued a Request for Tender (RFT) for the existing building and site demolition for the new St. Frances Cree Bilingual School.

These RFT was posted on SaskTenders to satisfy the requirements of the New West Trade Partnership Agreement. The RFT close date was June 22, 2021 at which time Greater Saskatoon Catholic Schools received four tender responses for the project.

The tender responses ranged from \$279,100 to \$354,780 plus PST and GST.

Silverado Demolition Inc. was the lowest tender price.

Recommendation:

That the Board of Education award the tender for existing building and site demolition to Silverado Demolition Inc. for the tendered price of \$279,100 plus applicable taxes.
