Background Information:

Greater Saskatoon Catholic Schools (GSCS) offers transportation services to 6,427 students daily. Rural students who attend a GSCS school in the town of Biggar, and the cities of Humboldt, Warman, and Martensville are jointly transported with the public school divisions in each of the respective areas.

The following summary is the transportation services provided to students who attend a school located in Saskatoon and one immersion bus to École Holy Mary School:

1. First Canada ULC Transportation Statistics as of April 30, 2024

- Total Students Transported (registered) 3,653
- In-Town Students Transported 3,366
- ❖ Transportation Routes 97
- Average Age of Bus Fleet 6 Years
- Capacity Utilized On Bus (Average) 84%
- ❖ Average One-Way Ride Time By Route 25 minutes
- Longest One-Way Ride Time By Route 75 minutes (École française de Saskatoon [Saskatoon French School])

2. Hertz Northern Bus Transportation Statistics as of April 30, 2024

- ❖ Total Students Transported (registered) 2,774
- ❖ In-Town Students Transported 2,746
- Transportation Routes 49
- ❖ Average Age of Bus Fleet 8 Years
- ❖ Capacity Utilized On Bus (Average) 100%
- ❖ Average One-Way Ride Time By Route −20 minutes
- Longest One-Way Ride Time By Route 60 minutes

6.2 Local Implementation and Negotiations Committee Agreement

Background Information:

The current Local Implementation and Negotiations Committee (LINC) Agreement is scheduled to expire August 31, 2024 after 'rolling over' the last two years.

The Saskatoon Teachers' Association (STA) and LINC executive have once again brought forward the idea of 'rolling over' the agreement for another year. This comes primarily from the LINC executive's acknowledgement of the uncertainty and challenge created by the provincial collective bargaining process and associated job action.

The roll-over would, once again, secure the terms and conditions for teachers for another year. The one-year roll-over to the LINC Agreement would see no change to language. However, should something pressing arise, amendments can always be achieved by mutual consent of the parties through letters of understanding.

Recommendation:

That the Board of Education approve the roll-over to the current LINC Agreement (set to expire August 31, 2024) for the 2024-2025 school year (expiring August 31, 2025).

Background Information:

In March 2024, Greater Saskatoon Catholic Schools, in partnership with Edwards Edwards McEwen Architects, issued four Requests for Tender (RFT) for the construction of (1) relocatable classroom as part of the 2023-2024 Relocatable Classroom Program. The RFT was posted on SaskTenders to satisfy the requirements of the New West Trade Partnership Agreement and the Canadian Free Trade Agreement.

Father Vachon School - One classroom:

- Tender Close Date April 16, 2024 at 2:00 p.m.
- Three bids, tender responses ranged as follows:
 - \$457,000 to \$630,000 plus PST and GST
 - Schedules ranged from 14 to 30 weeks.

Based on tender pricing, the funding allocation from the ministry aligns with our project budget. This includes the relocatable classroom construction as well as furniture and consulting fees. A Letter of Intent subject to Board of Education approval was issued to Westridge Construction Ltd. The start-up meeting was held on April 25, 2024.

Provincial Relocatable Data

This year, funding was approved for 70 new relocatables and two relocatable moves for schools with 2024-2025 projected utilization rates of at least 111%.

6.4 Cybersecurity Managed Detection and Response Service Contract

Background Information:

The need for a solution like Arctic Wolf arises from the increasing cyber threats faced by organizations, including malware, phishing attacks, and other forms of cyber-attacks. These threats necessitate proactive managed monitoring and detection to protect sensitive data and ensure the security of key stakeholders, including users and students. Arctic Wolf, founded in April 2012, has been providing Managed Detection and Response (MDR) and Security Operations Center as a Service (SOCaaS) for over a decade, with a focus on optimizing existing technology infrastructure and implementing comprehensive security operations frameworks. SaskTel has partnered with Arctic Wolf as a premier partner to deliver this service in Saskatchewan.

Why Arctic Wolf + SaskTel?

Arctic Wolf offers a tailored security solution that includes Managed Detection and Response (MDR), Managed Risk (MR), and Managed Security Awareness (MSA) services. These services are designed to assist organizations in promptly identifying and mitigating threats without the need for additional staffing. The solution is deployable within 14 business days and integrates seamlessly with existing infrastructure. Arctic Wolf's approach emphasizes operational effectiveness, with human expertise integrated into the cybersecurity process, recognizing the need for adaptability in defending against evolving threats.

Breakdown of Costs

The contract with Arctic Wolf is a 3-year term with a total contract value of \$946,414.59 + tax.

These costs include subscription fees and one-time fees for services such as onboarding and shipping of necessary hardware. The pricing summary also details the costs associated with user licenses, server licenses, log retention, and other services provided by Arctic Wolf.

In addition to the contracted services, Arctic Wolf offers a Security Operations Warranty, which provides up to \$1,000,000 USD in financial assistance for cybersecurity incidents, subject to the customer meeting certain subscription criteria.

Justifications

Cybersecurity professionals are indeed in high demand, leading to higher costs for organizations to maintain in-house cybersecurity teams. Outsourcing cybersecurity to a Canadian company like Arctic Wolf can be a cost-effective solution. Arctic Wolf has positioned itself to meet the comprehensive cybersecurity needs with a solution package.

This comprehensive approach by Arctic Wolf demonstrates their capability to provide a robust cybersecurity solution that aligns with the needs and requirements of organizations looking to monitor and respond, manage and identify cyber risk, and provide user training made them an ideal partner.

Provincial Procurement

As part of this procurement, Greater Saskatoon Catholic Schools listed all other Saskatchewan school divisions as potential additions to our contract award. As of May 9, 2024, 17 school divisions requested pricing from Arctic Wolf based on this procurement. The Cyber Risk WAG with the Saskatchewan School Boards Association (SSBA) has also decided to use this procurement to support their work.

Background Information:

On March 21, 2024, Greater Saskatoon Catholic Schools, issued a Request for Quotation (RFQ) for a Vendor of Record for the provision of Juniper hardware (access points, switches and firewalls) and software (licenses, subscriptions and feature sets).

This RFQ was posted on SaskTenders to satisfy the requirements of the New West Trade Partnership Agreement and the Canadian Free Trade Agreement. The RFT close date was March 24, 2022, at which time Greater Saskatoon Catholic Schools received one quotation response for the project.

The tender response received from Charter Telecom Inc. resulted in projected savings of \$275,000 annually. The annual projected spend per year is between \$800,000 and \$1,400,000.

The contract term is a three-year term with the right to extend the contract for two additional one-year terms for a total contract length of five years. The contract allows for all school divisions within Saskatchewan to take advantage of the Juniper pricing. Unit pricing will remain consistent throughout the life of the contract, with the exception of currency fluctuations.

Recommendation:
