Notes

1. It is expected that the total of property taxes and grants will be over budget by \$3 million due to being 500 students over enrolment projections on September 30th.
2. Early learning intervention funding received in excess of budget.
3. Interest revenue and cafeteria sales are trending to be over budget, while noon lunch supervision fee is under budget due to later implementation.
4. Governance expected to be on budget by year-end.
5. Instruction will be over budget due to being over enrolment projections by +1,200 students with the ministry only funding 500 of those students.
6. Tuition and related fees expenses are incurred unevenly during the year.
7. School generated funds expenses are incurred unevenly during the year and a disproportionate amount are incurred in the last two months of the school year.
8. Pre-kindergarten program is under projection and allocated resources were redeployed to support kindergarten programs students.

6.2 Transportation Monitoring Report

Background Information:

Greater Saskatoon Catholic Schools (GSCS) offers transportation services to 5,813 students daily. Rural students who attend a GSCS school in the town of Biggar, and the cities of Humboldt, Warman, and Martensville are jointly transported with the public school divisions in each of the respective areas.

The following summary is the transportation services provided to students who attend a school located in Saskatoon and one immersion bus to École Holy Mary Catholic School:

Background Information:

The purpose of this report is to provide updates to the board regarding the consultations and surveys that took place between December 2022 and March 2023 specific to the core French programming at St. Edward School. The summary of the consultation process is listed below:

- 1) December 2022 – Request emerging from the CSCC regarding a review of the core French programming offered at St. Edward School
- 2) January 2023 – Community consultation meeting at the school
- 3) January 2023 – Electronic survey (on Edsby and email) to all families to allow them to share their interest, questions and comments around French language programming
- 4) Mid- to late February 2023 – Each family who had not yet responded to the online survey received a phone call from school administration
- 5) Mid-March 2023 – Results of the survey were shared with the CSCC
- 6) Mid-March 2023 – Results from the survey were shared with the school community via a Google Form and feedback was once again sought
- 7) End of March 2023 – Results and additional feedback survey was closed with very limited responses

The feedback provided by the families makes up one of the four parts of The *Second Language Learning – Other than English* administrative policy that outlines the board's right to determine the location for language learning offerings. Staffing and a commitment to the programming were the two other sections of the policy that were considered as a part of the review process.

In reviewing all the feedback gathered during the above-mentioned process, administration recommends the French language programming be discontinued for the fall of 2023 at St. Edward School.

Recommendation:

That the Board of Education approve discontinuing French language programming for the fall of 2023 at St. Edward School.

6.4 Preventative Maintenance and Renewal Plan



Board Priority:

Background Information:

Greater Saskatoon Catholic Schools will receive \$3,823,252 in Preventative Maintenance and Renewal (PMR) funding as part of the 2023-2024 provincial budget. This is a decrease of 9.03% or \$379,443 less funding compared to the 2022-2023 allocation.

PMR funding allows the board to take a strategic approach to on-going maintenance and replacement of school building components. School divisions are permitted to re-prioritize projects within the plan and respond to emerging or unforeseen facility demands during the year. The following four-year PMR plan requires board approval and submission to the Ministry of Education prior to approving the PMR projects listed.

The board is required to submit a 2023-2024 plan to match funding, but this does not reflect all ongoing or deferred PMR costs. The estimated annual costs of 2024-2025 and beyond is more reflective of what PMR funding should be.

6.5 École Saskatoon French School Roof Replacement

Background Information:

On April 5, 2023, Greater Saskatoon Catholic Schools, in partnership with Edwards Edwards McEwen Architects, issued a Request for Tenders (RFT) for the roof replacement at Saskatoon French School in Saskatoon.

This RFT was posted on SaskTenders to satisfy the requirements of the New West Trade Partnership Agreement and the Canadian Free Trade Agreement. The RFT close date was April 25, 2023 at which time Greater Saskatoon Catholic Schools received six tender responses for the project.

The tender responses ranged from \$207,600.00 to \$304,000.00 plus PST and GST.

Haid Roofing Ltd. provided the lowest tender price for the project.

Recommendation:

That the Board of Education award the tender for the École Saskatoon French School roof replacement to Haid Roofing Ltd. for the tendered price of \$207,600.00 plus applicable taxes.

World Catholic Education Week: This Sunday, May 14, marks the beginning of Catholic Education Week and continues through to Saturday, May 20 with World Catholic Education Day on Thursday, May 18, 2023. The theme for this year is ***We are Many, We are One / À plusieurs, nous sommes un.*** - *"We, who are many, are one body in Christ, and individually we are members, one of another."* (Romans 12:5).

The sub-themes for each day this week are:

- Monday: When We See / En voyant
- Tuesday: When We Listen / En écoutant
- Wednesday: When We Reflect / En réfléchissant
- Thursday (World Catholic Education Day): When We Learn / En apprenant
- Friday: When We Act / En agissant

Provincial Education Priority Action Plan: The Draft Provincial Education Priority Action Plans were shared with all directors of education on May 2. Provincial leadership teams have spent the last six weeks developing these plans. Executive Council members from Greater Saskatoon Catholic Schools are part of each of the provincial teams. We look forward to using the provincial plans to continue our division level work with school leadership teams.

St. Michael Métis School of Excellence - Old Thyme Dance Party: St. Michael Métis School of Excellence hosted the second Old Thyme Dance Party of the year on April 19. A great big thank you to our FNMIE team, CUMFI and the staff at St. Michael for hosting this amazing cultural community builder. Young and old participated in the dance and all were treated to dances from the Creeland Dancers.

Catholic Connections Network-Saskatoon: The Catholic Connections group met on April 20 at Queen's House Retreat and Renewal Centre to continue the tradition of sharing our learnings as Catholic organizations. This partnership meeting allows leaders within all of the Catholic organizations in Saskatoon to learn from each other and stay up to date on innovations within each organization.

Greater Saskatoon Catholic Schools' Administrator Mentorship: Our administrator (vice principals and principals) mentorship program continued its work over the course of this year. Thanks to the leadership of our folks, the program was, once again, very successful. Our Vice/Assistant Principal's Association takes a lead role in bringing together experienced and neophyte administrators to help support our new leaders. The reality is that our experienced administrators learn a great deal from the mentorship process as well! Special thanks to the Vice/Assistant Principal's Association and Superintendent K. Cardinal and L. Giocoli Clark for their leadership of this important work. The final gathering and celebration at the conclusion of this 2-year program was held on May 9.

2023 Mosaic School Nutrition Challenge: Bishop Murray High School is the recipient of the 2023 Mosaic School Nutrition Challenge. This award, presented by the Minister of Education and the Saskatchewan School Boards Association (SSBA), is in recognition of the important efforts to provide the students with healthy lifestyle choices, proper nutrition, and nutrition education. The award comes with a \$15,000 prize to continue this great work.

Treaty 6 Medal Installations: Our schools continue the process of learning about treaties. The learning process begins in the fall and concludes with the action of installing the Treaty 6 Medal in their school. At this time, most of our schools have completed the process. Since last spring, the following schools have completed this action:

- St. Philip School
- St. Mark School
- Georges Vanier Catholic Fine Arts School
- St. Joseph High School
- École St. Peter School
