6.1 Northern Lights Movement for Kids

Board Priority:

- Improving Student Learning and Achievement
- Building Relationships and Partnerships
- Promoting Stewardship

Presented by: Superintendent G. Martell, Vice Principal Celeste Leray-Leicht and Coordinator Cornelia Laliberte

Background Information:

The Northern Lights Movement for Kids is contextualized by Canada's largest class action lawsuit, the Indian Residential School Agreement, and the resulting establishment of the Truth and Reconciliation Commission (TRC). In 2015, the Truth and Reconciliation Commission of Canada issued their final report which included 94 Calls to Action. The Calls to Action were intended for all Canadians to work together and begin the process of reconciliation. Section 63(iii) of the TRC Calls to Action states, "we call upon the Council of Ministers of Education, Canada to maintain an annual commitment to Aboriginal education issues, including: building student capacity for intercultural understanding, empathy, and mutual respect."

The Northern Lights Movement for Kids was inspired by Celeste Leray-Leicht's refection that since the release of the Truth and Reconciliation Commission's (TRC) Calls to Action in 2015, Saskatchewan continued to witness manifestations of disparity and hopelessness including the tragedy in the northern village of La Loche in 2016 and the ongoing youth suicide crisis in northern Saskatchewan. In 2018, the Humboldt Broncos tragedy claimed the life of Celeste's son, Jacob Leicht. It was in the days following that tragedy that Celeste's personal Call to Action precipitated the Northern Lights Movement for Kids.

Celeste and Coordinator Cornelia Laliberte will provide a virtual presentation at the meeting.

The Northern Lights Movement for Kids

The intention of the Northern Lights Movement for Kids is to provide opportunities for youth from Indigenous and primarily non-Indigenous communities to build relationships, make connections and serve others. Initially it began with making connections to La Loche. A pen pal relationship with students from a variety of classes from Ducharme Elementary School and Dene High School in La Loche emerged. Then students from Dene High School came to the Greater Saskatoon Catholic Schools' Student Leadership Conference last fall and met with students from St. Dominic and St. Augustine Schools in Humboldt. The students then met virtually after the Student Leadership Conference and took a virtual tour of Saskatchewan together, especially the communities of La Loche and Humboldt. Ducharme Elementary School in La Loche has now joined in the 'Great Prairie Race'; promoting it to as many schools as possible throughout the prairie provinces.

The Northern Lights Movement for Kids has engaged in various acts of community service, including:

- Washing seats at the Elgar Petersen Arena in Humboldt with a group of students from Humboldt Collegiate Institute.
- Sending handmade cards to St. Mary's Villa Special Care Home in Humboldt at Christmas
- Sending Valentines to Jim Pattison's Children's Hospital.
- Holding a bake sale with proceeds, along with handmade cards and Hershey Kisses & Hugs, going to Makwa Sahgaiehcan First Nation upon hearing of the news of their plea for help in addressing suicide among their youth.
- Playground cleanups.
- Building Relationships and Making Connections with Pinehouse through the "My Sky is Your Sky is Our Sky" May long weekend photo sharing between the Pinehouse Photography Club and Humboldt Collegiate Institute Photography Club.
- The "111 KM Challenge" in June (walk/run/bike/wheel) and the "Summer Snowball 111 KM Challenge" (on land or water) in July and August.
- Bringing awareness to the Northern Lights Movement for Kids with participation from four provinces, two states in the U.S., as well as Japan and Australia.
- Creating a new and official Northern Lights Movement for Kids logo, clothing and paraphernalia for promotion and prizes.
- "The Great Prairie Race" communities tagging one another to remove the distance between each other's homes and meeting virtually.

What's Next

Building on the successes of the Northern Lights Movement for Kids and the awareness that it has brought to connecting youth and focussing on relationship and healing, work to expand the initiative includes:

- Further promotion of "The Great Prairie Race."
- Development of an organizational website.
- Soliciting partnerships with other school divisions, First Nations organizations, the broader hockey community, businesses, and government.
- Soliciting sponsorship from athletic wear businesses, National Hockey League teams or
 players to offer winter athletic outer wear or equipment for Great Prairie Race participants
 as prizes.

Personal and organizational Calls to Action, big or small, help to create the kinds of communities that we aspire to and that offer children and youth opportunity to grow in an environment of self-worth and to see themselves as an integral part of the future. The connections between communities that have been established through the Northern Lights Movement for Kids exemplify reconciliation and instill hope that through relationships and healing, good will prevail and the commitment to "...building student capacity for intercultural understanding, empathy, and mutual respect" is one step closer to being realized.

Notes

- 1. The Ministry of Education reconciles property taxes collected each month and adjusts the operating grant received by the division. The net result is that property taxes and operating grant combined are on budget.
- 2. School based revenue will be under budget this year due to pandemic school closures.
- 3. Reimbursements from third parties and interest were trending to be in excess of budget as of July 31. Food sales will end the year short of projections due to pandemic school closures.
- 4. Completion of the Board Office roof and window wall refurbishment project.
- 6. School based expenses will be under budget this year due to pandemic school closures.
- 7. Budget for intensive supports pre-kindergarten equipment carried over from the prior year was not fully spent.
- 8. Current interest is under budget, line of credit not needed so far this year.

Background Information:

At each board meeting, administration provides an update regarding the division plans and responses as a result of the COVID-19 pandemic impacting our communities. This report raises items since the last report and does not restate on-going response items.

Division Plans

The GSCS Return to School Plan that was released on August 4, 2020 has been in operation since then. As new information or direction surfaces, the plans have been adjusted accordingly. This is indeed an evergreening document and will continue to be for the foreseeable future. By and large, the initial plan has remained consistent. The planning work done by the many division teams has proven to be very accurate, helpful and appropriate for the circumstances. The teams continue to meet as needed to revise and adapt plans based on new learnings. This process will continue.

Concerted planning has gone into preparations for the possibility of a classroom or school needing to move to on-line learning for a period of time. Plans were put to the test this past week when the situation at Fr. Vachon School prompted the Saskatchewan Health Authority to recommend closure of face-to-face learning until October 21. Thus far, plans have proven to be supportive of a good transition. As this first situation resolves, we will review and adjust our plans accordingly.

As cases have come to light in schools, the process to inform and support the community has been effective and has been improved with experience. The flowcharts shared previously have worked well.

Distance Learning

The K-12 Distance Learning option is fully up and operational now. The K-8 portion continues to serve approximately 1,300 students.

QR Visitor Code

The process we developed to help track the limited visitors we have in schools has proven to be effective and helpful. The contact tracing component of work that follows a positive case needs to happen quickly and be accurate. This has been a helpful tool for our work and the work of SHA.

Conclusion

The numerous layers and components of the Return to School Plan have meant a great deal of change and hard work on behalf of every role in the division. There is no role that has not been impacted by the new requirements. As we now have approximately six weeks of experience with the new requirements, staff are all to be thanked for their diligent work in implementing these requirements. Despite the challenges, they have done a remarkable job in finding ways to fulfill the requirements yet provide the best experience of Catholic education that they can. Given that, according to the CMHO at SHA, there does not appear to be transmission at school, one can see that the layers of the plan appear to be working and providing the required safety measures to inhibit transmission at school. As the trajectory of this pandemic changes though, our plans and requirements need to remain nimble and responsive to what might yet be in store.

6.5 45th Street Service Centre Property Purchase Agreement

The new Service Centre on Fletcher Road is progressing on schedule and will be ready for occupancy next month. As part of the Service Centre Replacement Project, the existing building on 45th Street was to be sold and the proceeds of the sale will fund the renovation costs of the new building. The service centre was listed for \$1.75 million and administration accepted a counteroffer from Lucania Holdings LTD for \$1.6 million. The sales agreement is pending board approval which is required prior to the possession date of December 15, 2020. The agreement is also pending inspections that the purchaser will complete by November 13, 2020.

Director's Report October 19, 2020

Weekly pandemic meetings:

Various levels of weekly meetings continue to happen to support on-going integrated planning and responses both internally and externally. Each group reviews the current and near-term future status and establishes any adjustments necessary. The flow of information and planning has improved over time and is quite efficient at this point. Related to this point are the continued meetings and communications with other important local groups to keep connected and discuss issues that arise as we work through these very different times. We connect regularly with groups such as our CUPE 2268 and 3730 Local Executives, Teacher Relations Committee, Saskatoon Teacher's Association President and Executive, etc. etc. While it is challenging to find time to connect, it is important to work at keeping communication flowing in both directions. So much has and is changing that unintended issues arise and need to be worked through. We are blessed to work with extremely supportive and dedicated groups and leaders!

māmawohkamātowin Governance Committee:

The first meeting this year of the māmawohkamātowin Governance Committee took place on September 17. Representatives reviewed the revised planning framework to support the move to detailed design for St. Frances Cree Bilingual School as well as reviewing a process to support co-governance discussions. The next meeting will take place once elections for both entities have been completed and committee member determinations have been made.

Saskatchewan Catholic School Boards Association:

A virtual meeting of the board of directors for the Saskatchewan Catholic School Boards Association took place on September 19. Both the Education Committee and Board of Directors meetings took place virtually.

Education Sector Strategic Plan:

It has been confirmed now that due to the major impact of the pandemic on our sector, we will be moving forward with an additional year of the Education Sector Strategic Plan (ESSP). With the ESSP due to have wrapped up in June, the Provincial Leadership Team combined with the pending Provincial Education Plan Leadership Team, felt that this was the most prudent course of action. As this involves some assessments that are gathered provincially, more information will be coming on their status soon. Regardless, local boards will be able to implement any of the assessments as we are able to. It should be noted that the assessments that were slated for the last part of last academic year were cancelled, therefore our data sets available for analysis and planning this year are very much impacted.

Orange Shirt Day:

September 30, designated Orange Shirt Day, was once again observed in our school division. Given some of the limitations, staff were very creative in ways to still take time on this day to deepen our understanding of Residential Schools, their lasting impact, and recommit to our work towards reconciliation.
